

In order for INFINITY FLOOR to open your account and extend credit to your business for the purchase of our goods and services, you must submit a new customer/credit application through this website. As you complete the application, you will be asked to provide certain information about your business. Your application cannot be processed unless all of the requested information has been entered.

Because your web browser will timeout if no information has been entered within a five minute period, you should gather all of the necessary information before beginning the application process. Note: You can save your progress and come back to a link that will be emailed to you to finish when you choose.

That information will include:

- 1) your name and title, the legal name of your business and any other names your business uses, the date your business was established, the address, telephone number, fax number, email address, and federal tax identification number of your business;
- 2) the names, addresses and social security numbers of the principal owners or officers of your business;
- 3) the name of your bank, the name of your contact at that bank, the telephone number for that contact, and your account number at that bank;

Infinity Floor Customer Account Terms and Conditions

1. Independent Entity

Infinity Floor, LLC ("Infinity Floor") operates as a separate entity, unaffiliated with any past employers of its personnel. Past associations of personnel do not imply any relationship or endorsement.

2. Voluntary Application

By submitting this application, you confirm it is a voluntary decision and that no Infinity Floor representative solicited or pressured you.

3. Account Approval

Infinity Floor reserves the right to approve or deny applications at its discretion. Approval does not obligate Infinity Floor to extend credit or continue business relations. Accounts may be limited, suspended, or terminated as deemed necessary.

4. Payment Terms

Payment is due per agreed terms, regardless of any claim or dispute, which must be submitted and approved by Infinity Floor in writing before any deductions.

5. Claims and Disputes

Claims must be filed within the specified timeframe according to Infinity Floor's policies. Failure to follow the procedure may waive your claim rights.

6. Data Protection

Customer data is handled according to data protection laws and will not be shared without consent, except for necessary business functions or as required by law.

7. Liability Limitation

Infinity Floor is not liable for indirect or consequential damages, including lost profits. Total liability will not exceed the amount paid for goods or services in the prior 12 months.

8. Indemnity

You agree to indemnify and hold harmless Infinity Floor and its affiliates from any claims or damages resulting from your breach of these terms.

9. Accuracy of Information

Information provided in the application must be accurate. False information may result in immediate termination or denial.

10. Governing Law

These Terms are governed by the laws of Georgia, and disputes will be resolved in courts within that jurisdiction.

11. Agreement and Amendments

These Terms represent the full agreement between you and Infinity Floor. Infinity Floor reserves the right to amend Terms, effective upon posting or written notice. Continued account use constitutes acceptance.

12. Severability

If any part of these Terms is found invalid, the remaining provisions continue in effect.
